AN ORDINANCE AMENDING SECTION 368.301 (VIOLATIONS AND CRIMINAL PENALTIES), PART 3 (ENFORCEMENT), CHAPTER 368 (NOISE CONTROL), ORDINANCE CODE, SECTION 614.103 (RESERVED), CHAPTER 614 (PUBLIC ORDER AND SAFETY), ORDINANCE CODE, SECTION 632.101 (CLASSES OF OFFENSES), CHAPTER 632 (PENALTIES), ORDINANCE CODE, SECTION 656.1309 (UNLAWFUL SIGN MESSAGES), PART 13 (SIGN REGULATIONS), CHAPTER 656 (ZONING CODE), ORDINANCE CODE, AND SECTION 741.107 (VIOLATIONS AND CRIMINAL PENALTIES), PART 3 (ENFORCEMENT), CHAPTER 741 (ZERO TOLERANCE ON LITTER), ORDINANCE CODE, TO ENHANCE CIVIL AND CRIMINAL PENALTIES FOR VIOLATIONS OF CITY CODES WHEN SUCH VIOLATIONS WERE MOTIVATED BY HATE; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION INSTRUCTIONS; PROVIDING AN EFFECTIVE DATE.
